# MANAGING DIRECTOR REPORT

Ratification of the Budget Transfer for Primary Road Funding in 2019 – Managing Director Fred Peivandi, thanked the Board for ratifying the four million dollar budget transfer for primary road funding in fiscal year 2019. Managing Director Peivandi stated these repairs are badly needed.

#### **COMMISISONER"S CONCERNS**

Bridges in Genesee County - Commissioner Arceo commented on Correspondence Item D-2, "Roads get spotlight, but 447 Michigan bridges in serious condition or worse", by Lindsay VanHulle, May 13, 2019. Commissioner Arceo asked staff how many bridges are in Genesee County. Engineering Director, Eric Johnston stated that Genesee County has over 120 bridges that we oversee in the county and over half of them are 80 to 100 years old. Mr. Johnston said the life expectancy of a bridge is approximately 75 years and our goal is to have primary road bridges in good shape. The Road Commission will be replacing seven (7) bridges and two (2) large culverts in the county in 2019.

<u>GCRC Maintenance Department Summer Schedule 2019 Booklets</u> - Commissioner Arceo thanked Maintenance Director Anthony Branch for the Maintenance Department Summer Schedule 2019 handouts.

<u>Road Commissioner Contact Numbers</u> - Commissioner Kautman-Jones asked that staff provide the phone numbers of the Road Commissioners to the Board of County Commissioners so that they may contact them directly. Staff stated that they would provide this to the County Board members today.

<u>Petty Cash Fund Policy</u> - Commissioner Kautman-Jones asked staff if the Road Commission had a petty cash fund policy in place. Commissioner Kautman-Jones had noticed checks that were issued to employees for amounts under \$10.00 in the vouchers. Staff stated that the GCRC does have a petty cash account but we do not have a policy in place. Staff stated that they would work on a policy.

<u>Salary Increase for Road Commissioners</u> - Chairperson Mandelaris thanked Managing Director, Fred Peivandi for his assistance at the County Board meeting this morning. The County Board authorized a salary increase for the Road Commissioners at this morning's Board Meeting. Members will receive \$9,000 annually and the Chairperson will receive \$11,000 with no fringe benefits. Chairperson Mandelaris stated that the vote was 8:1 and there is no retroactivity under the statute. The increase will become effective on May 21, 2019.

Human Resource Director, Donna Poplar stated that the Road Commission would need documentation from the county regarding the approval for the Road Commissioners increase in pay. Managing Director Peivandi answered that this would be provided at a later date.

Commissioner Kautman-Jones would like to make a motion reflecting this increase in the minutes.

<u>ACTION TAKEN</u> - Motion by Ms. Kautman-Jones, seconded by Mr. Arceo, that the Board of County Road Commissioners accept the salary recommendation from the Genesee County Board of Commissioners in the amount of \$9,000 per year for members and \$11,000 per year for the Chairperson, effective Tuesday, May 21, 2019.
