Pierson Road, thanked staff for addressing the drainage issues on Dillon Road and W. Pierson Road in Flushing Township. (Copy filed with official minutes.)

Correspondence from Supervisor Oskey, re: Linden Road Traffic Study, Mundy Township – In correspondence dated September 22, 2020, Mundy Township Supervisor, Joe Oskey, requested a traffic study to determine the feasibility or need for a road diet on Linden Road between Hill Road and Maple Avenue in Mundy Township. (Copy filed with official minutes.)

Ms. Kautman-Jones asked what the process involves. Mr. Peivandi responded that a pavement marking plan is inexpensive and involves making sure the existing signals line up with the proposed pavement markings. The road diet was scheduled last year but was not completed. The work will be scheduled in the spring. Ms. Kautman-Jones asked if a traffic or speed study are needed. Mr. Peivandi answered that if daily traffic counts are less than 10,000 on a multilane road, it qualifies for a 4-to-3 lane road diet. Mr. Johnston added that the Township asked for a study and the results are in outgoing correspondence. Mr. Arceo is concerned about road dieting and asked if we have any similar areas in the county. Mr. Peivandi said that we have many roads in the area that have gone from 4 lanes to 3 lanes. Mr. Johnston said that the study has been submitted to the Township and that GCRC is waiting for direction. Mr. Mandelaris asked if there will be a change in the speed limit. Based on the number of driveways, Mr. Johnston said that the plan is to keep the speed at 45 mph.

BOARD OF ROAD COMMISSIONERS' DECISIONS

DISCUSSION

Amendments to the Michigan County Road Commission Self-Insurance Pool By-Laws – In a memorandum dated September 28, 2020, staff requested Board approval for the amendments proposed to the Michigan County Road Commission Self-Insurance Pool By-Laws proposed by MCRCSIP. (Copy of memorandum filed with official minutes.)

Mr. Mandelaris noted that the amendments were sent to all road commissions and that there is ambiguity with respect to what was to be done. Mr. Mandelaris asked if Managing Director Peivandi approved the proposed amendments. Mr. Peivandi replied yes. Ms. Kautman-Jones asked if Mr. Peivandi is seeking Board support to vote 'yes' on the amendment. Mr. Peivandi replied yes. Mr. Johnson asked if the County Board ever elects to take over GCRC, are we still a member. Mr. Peivandi replied that we would be a non-voting associate member if we became a DPW for the County, but that right now GCRC is a voting member. Ms. Kautman-Jones noted that some counties have DPWs but still want MCRCSIP to represent them, which is what prompted these by-law amendments.

MANAGING DIRECTOR REPORT

Ms. Donna Poplar announced that based upon last week's Supreme Court ruling concerning the Governor's executive order, a decision was made by the Genesee County Health Department under the leadership of John McKellar and Gary Johnson, along with the Genesee County Board of Commissioners, to remain status quo with our current COVID response plan. Our attorney, Wendy Hardt, advised to remain status quo for the next 21 days. Managing-Director Peivandi said that Attorney Hardt advised that we may be required to have in-person Board meetings on October 23rd, which is 21 days after the Supreme Court ruling. Mr. Mandelaris believes that was only an advisory opinion. Ms. Kautman-Jones said that Michigan Department of Health and Human Services, which is over all of the Health Departments, issued an order which is different. Employers will be dealing with constantly changing information. Organization have to continue doing what they have been doing in the best interest of all of the people. Ms. Poplar said that no employees have tested positive for COVID and what GCRC is doing as an organization is clearly working.

Managing Director Peivandi presented a plaque that GCRC received for last year's participation in Back to the Bricks. Mr. Dellaposta thanked all of the participating employees for their time and energy. Ms. Kendra Love-Brezell did a phenomenal job organizing things. GCRC would have participated this year except for COVID.

COMMISSIONER'S CONCERNS

Ms. Shirley Kautman-Jones announced two upcoming virtual County Road Association public relations workshops on October 13th and 27th from 10:00 a.m. until noon. Each person wishing to participate needs to register. Mr. Peivandi will have the workshops set up in the GCRC Board Room.

Ms. Kautman-Jones asked how the virtual ERACE sessions worked out. Ms. Poplar said that the presenters were awesome and that the cooperation of the 40 participants was very good. Ms. Kautman-Jones asked if this organization has ever participated in workshops related to reverse discrimination. Ms. Poplar stated that this organization is just starting to deal with systemic racism. Positive changes can take place here.

Mr. Arceo asked how many roundabouts we have in Genesee County. Mr. Johnston answered that there are five currently operating (including one in the City of Fenton), three more will open to traffic this fall, and one more in the spring. Mr. Arceo asked if the lighting of roundabouts is GCRC's responsibility. Mr. Peivandi answered that lighting installation is part of the construction cost and that the Township pays for the energy usage. Mr. Arceo is concerned about safety in the evenings of the roundabouts that are not well lit, such as Seymour Road, Grand Blanc Road and Rolston Road. Ms. Kautman-Jones said that clusters of businesses can provide ambient lighting, but that drivers should not have to rely on the headlights of other vehicles to give you lighting on a roundabout. Mr. Peivandi said that roundabouts have plenty of advanced warning signs and speed limits of 15 mph. Mr. Johnson agreed that drivers need to look at the signs. Mr. Johnston said that it would not take much effort for staff to look at the locations at night.

Mr. Dickerson commended all employees and said that it is a blessing that no employees have tested positive for COVID. Mr. Dickerson said that Mr. Peivandi has done a great job, along with Ms. Poplar, in making people aware of what is going on.
