MANAGER-DIRECTOR REPORT

Mr. Fred Peivandi updated the Board as to the status of active construction projects. Flushing Road is completed and opened to traffic; Hill/Belsay Roundabout will reopen this week; Fenton Road is one month ahead of schedule; Seymour Road is two weeks behind schedule; and Coldwater Road is ahead of schedule and expected to reopen in two weeks.

Mr. Randy Dellaposta informed the Board of his recent meeting with the auction company, Last Bid Real Estate (LBRE), regarding the sale of 310 W. Oakley Street. LBRE has a two month process and a 95% success rate. Mr. Dellaposta explained that if the property is auctioned, it is sold "as is" and no building repairs will be necessary prior to sale. GCRC would be required to pay any mass media costs, estimated at \$2,500 - \$5,000. Mr. Dellaposta will ask LBRE to do a presentation at the next Board meeting. At the next Board meeting, Commissioner Arceo would like to know how much money GCRC has invested in the property to date.

Mr. Randy Dellaposta said that the attorneys are writing a new land lease agreement for the Kipp Road tower which is currently used for public broadcasting. The existing lease was written in 1978. Goodrich Tower will take over and get the tower up to par and provide quality service. Chairperson Kautman-Jones said that the big money is in co-location and wants that addressed in the new lease agreement.

COMMISSIONER'S CONCERNS

Vice Chairperson Mandelaris asked if Commissioner Henry's FOIA request has been completed. Staff answered yes.

Vice Chairperson Mandelaris asked if everyone will be attending the upcoming Diversity Training. Staff answered yes.

Chairperson Kautman-Jones asked if the RFP for legal services will be published on July 15th. Staff answered that it will be advertised with MITN, CRA, CAM, The Flint Journal and Crane. Bid letting will be July 30th.

Chairperson Kautman-Jones asked for an update on the selection of a website designer. Staff said that GovSites was selected by a committee of staff members who rated the 6 least expensive bidders by a set of criteria. GovSites has already started working on the new website which is expected to go live by the end of September. Chairperson Kautman-Jones requested that a calendar be included on the new website for events such as Board meetings and project start dates.
