### **BOARD OF COMMISSIONERS DECISION**

Chairperson Kautman-Jones requested a motion be made to go into closed session to discuss the employee concerns confidential survey with legal counsel pursuant to MCL 15.268(h) and MCL 15.243(1) (g) with Attorney Cliff Hammond of Foster, Swift, Collins & Smith.

<u>ACTION TAKEN</u> - Motion by John Mandelaris, seconded by Commissioner Arceo, to go into closed session to discuss the employee concerns confidential survey pursuant to MCL 15.268(h) and MCL 15.243(1) (g) with Attorney Cliff Hammond of Foster, Swift, Collins & Smith.

Commissioner Dickerson asked why Human Resource Director, Donna Poplar is not to be included in this closed session meeting.

Attorney Andrea Johnson stated that the purpose for this meeting is just to inform the Board of the results of the confidential employee concern surveys with legal counsel. This allows the Board to ask all of their questions in closed session with legal counsel.

Vice Chairperson Mandelaris asked Attorney Cliff Hammond whether or not the Human Resource Director and Finance Director should be included in the closed session. Attorney Hammond stated that is up to the discretion of the Board and his role here is to simply report his findings to the Board and let the Board make an educated opinion from the findings of the employee surveys.

Attorney Tom Derderian stated that he has serious questions whether the Board can go into closed session to review this document and discuss this matter. Attorney Derderian said he was not part of the confidential employee concern surveys.

Vice Chairperson Mandelaris said that in his opinion the Human Resource Director and Finance Director should be omitted from the closed session and pursuant to MCL 15.268(h) and MCL 15.243(1) (g), the Board can legally go into closed session to discuss this matter, [information subject to attorney-client privilege].

Attorney Devin Sullivan stated that if the Board did not retain Attorney Hammond's law firm to conduct the employee concerns confidential survey, there may be a question whether the Board can go into closed session to hear Attorney Hammond's recommendations. Vice Chairperson Mandelaris said the Manager Director has the authority from the Board to enter into contracts for the Road Commission.

Chairperson Kautman Jones asked for a vote on the motion to go into closed session pursuant to MCL 15.268(h) and MCL 15.243(1) (g) with Attorney Cliff Hammond of Foster, Swift, Collins & Smith, to discuss with legal counsel the employee concerns confidential survey [information subject to attorney-client privilege].
