<u>MDOT Contract No. 20-5280, Grand Blanc Road at Linden Road Roundabout, GCRC No. 66-W50240, Mundy Township</u> – In a memorandum dated June 29, 2020, staff requested Board approval for MDOT Contract No. 20-5280 for roundabout construction at the intersection of Grand Blanc Road at Linden Road in Mundy Township. Ms. Kautman-Jones noted that the Linden Road area is used by a lot of farmers and asked if farm equipment will fit through the roundabout. Mr. Johnston said that the design consultants are able to analyze the required design radius.

<u>GCRC Salary At-Will and Exempt Employees Salary Increases</u> – In a memorandum dated June 23, 2020, staff requested Board approval to increase the GCRC Director of Finance position salary from \$40.035 per hour to \$41.236 per hour, retro back to June 17, 2020. Also requesting approval to increase the salaries of GCRC salary at-will and exempt employees by 1%, effective October 1, 2020. (Copy of memorandum filed with official minutes.)

<u>ACTION TAKEN</u> – Motion by Mr. Arceo, seconded by Ms. Kautman-Jones, to approve the salary increase for the Director of Finance position as well as approve the 1% salary increase for all salary at-will and exempt employees.

Chairperson Dickerson questioned why the Finance Director is getting a 3% increase and the other directors 1%. Managing Director Peivandi said that Ms. Khan just finished her one year tenure and earns well below the other directors. Mr. Dickerson said that is because Mr. Peivandi set the Finance Director's incoming salary at \$80,000. Commissioner Mandelaris asked if the 1% versus 3% would cause descension among the employees and also stated he is in favor of the 1%. Commissioner Mandelaris noted that the two unions are in the process of negotiations and asked if it would be possible to come back to this issue for the at-will. Ms. Poplar supports giving Ms. Khan a 3% increase but questioned if the at-will employees should receive 3% or 1% increases. Ms. Kautman-Jones feels that this is a fair proposal as we do not yet know what funding will look like. As we move forward, if the Board feels people have been suppressed in

terms of wages, the Board can look at that. Mr. Dickerson feels it unfair to give Ms. Khan 3% but not the other directors and that the reason she is not on the wage scale is because that is how the Managing Director wanted it. Managing Director Peivandi asked that Ms. Khan now be put on the wage scale. Ms. Poplar feels that Ms. Khan's position should have been on the wage scale, as well as the positions of Mr. Johnston and Mr. Dellaposta. This issue will continue to be raised every time these positions get a raise. The proposed raise is not predicated on a formal performance evaluation. Commissioner Mandelaris asked if the Board should adopt a policy that future employees be hired on the wage scale. Ms. Kautman-Jones said that it deserves some discussion but she has no problem hiring someone on a lower wage for a probationary period. Ms. Poplar said that we need to be fair with Ms. Khan, Mr. Johnston and Mr. Dellaposta, the three directors not brought in on a wage scale. Ms. Poplar would like to create a wage scale that is applicable to them and acceptable by the Board. Managing Director Peivandi said that he suggested putting Ms. Khan on the wage scale at \$44.916 and Ms. Poplar opposed it. Ms. Poplar said that it would have been an 11.3% increase. Managing Director Peivandi countered that Ms. Poplar gave one of her employees a 20% increase and no one opposed it. Mr. Dickerson proposed a future closed door meeting with Attorney Tom Derderian on this issue. Ms. Kautman-Jones said that we need to be open to the idea that step increases and preset wages are not always in the best interest of an organization.

COMMISSIONER'S CONCERNS

Vice Chairperson Kautman-Jones asked when Roads & Bridges Advisory Committee meetings would resume. Managing Director Peivandi responded that they will resume when the building reopens to the public.

Vice Chairperson Kautman-Jones said that she had good discussions with State Representative Mike Mueller and his aide related to the Argentine Dam. Rep. Mueller understands where GCRC's commitment was and where the burden is on the residents that water serves as their lakefront property, not on the Road Commission. Managing Director Peivandi said that GCRC is meeting with a contractor on site tomorrow regarding repair of the shaft.

Commissioner Mandelaris said that Managing Director Peivandi's letter to Rep. Mueller was excellent.

Commissioner Mandelaris mentioned that the evaluation of the Managing Director occurs every two years but that since two members of the Board may not be here on that date, he suggested having the evaluation prior to the end of this year. Vice Chairperson Kautman-Jones thinks it is a great idea, is in favor of one year evaluations, and would like the issue on the next Board agenda. Commissioner Arceo concurred.

Commissioner Johnson asked when the Mt. Morris Road bridge replacement will be completed. Mr. Johnston replied that it will be completed at the end of this month.

Commissioner Johnson asked when the budget workshop is scheduled. Ms. Khan replied August 11th.

Chairperson Dickerson discussed his concerns of perceived racial and gender bias by the Managing Director related to black employees. Mr. Dickerson also described meetings with County Board members who had non-specified complaints against Mr. Dickerson. Mr. Dickerson also feels it is unfair that the County Board members wanted to remove Commissioners Johnson and Mandelaris. Mr. Dickerson thinks that the Managing Director initiated the complaints against the road commissioners. Managing Director Peivandi respectfully disagreed with everything Mr. Dickerson expressed. Commissioner Mandelaris described when he himself was sandbagged by County Board members on three occasions and feels it was a violation of Mr. Dickerson's constitutional rights for the County Board members to accuse him of things but not to name the source of the complaints. Commissioner Johnson said that Mr. Shumaker asked Mr. Johnson to resign so that a younger person could be appointed to the GCRC Board. Vice Chairperson Kautman-Jones was called to a meeting at the County, so she contacted Attorney Derderian who told her she did not have to attend, but that if she was compelled to attend, he would go with her. Mr. Dickerson said that he will not go to any meetings with County Board members without his attorney present.

Chairperson Dickerson, without objection, adjourned the meeting at 11:10 a.m.
