Commissioner Johnson stated that originally this road was to be used for emergency vehicles only. Commissioner Arceo commented that he has lived in this area for 62 years. In Mr. Arceo's opinion, the amount of traffic of commercial vehicles in this area has greatly increased even though the grade of this road has not changed. If you look at history, Mr. Arceo stated, the federal government funded the construction on Maple Road from Linden Road to Jennings Road. This allowed a 'Class A' road to be put in leading to Bishop Airport. The residents of Maple Road have absorbed the brunt of the increased traffic on this road. Mr. Arceo stated, the City of Flint, Mundy Township and Flint Township were all part of the original agreement and there was to be some funding to be distributed to each of these participators.

MANAGING DIRECTOR REPORT

4-10 Hour Shifts for GCRC Employees - Managing Director Peivandi stated that effective yesterday, March 16, all GCRC employees are working 4-10 hour shifts in order to lessen the contact with other employees due to the coronavirus pandemic. In addition, Mr. Peivandi stated that all Road Commission training is cancelled until further notice. Mr. Peivandi commented that we are following the State of Michigan's guidelines.

Chairperson Dickerson commented that he felt the Board should have been consulted before making a decision regarding staff working 4-10 hour days. Managing Director Peivandi responded that he had emailed the Commissioners last Thursday and consulted with all three unions before making this decision. Chairperson Dickerson would like staff to call him as opposed to emailing him.

Human Resource Director, Donna Poplar stated that she had made contact with Anita Galajda from the Genesee County Human Resource Department and County Commissioner Bryant Nolden regarding employee safety measures during the coronavirus pandemic. Ms. Poplar noted some safety measures the Road Commission should be considering include:

- Limiting entry to one door at all Road Commission buildings,
- Using gloves and sanitizer when processing the mail
- Remote staff meetings when possible
- Online Permits only
- Limit entry into the buildings to employees only

Managing Director Fred Peivandi asked Ms. Poplar to put these suggestions in writing for him. Ms. Poplar stated that she feels the Road Commission is being very proactive regarding the coronavirus safety measures. Commissioner Kautman-Jones indicated that the guidelines for safety measures will come from the CDC and with her business being a food manufacturing facility, she is updated constantly on safety protocol.

Commissioner Mandelaris asked Commissioner Kautman-Jones and Commissioner Arceo if they would be signing the documents in the Board packet this morning. Both Mr. Arceo and Ms. Kautman-Jones stated they would be in this afternoon to sign the documents.
