MANAGING DIRECTOR REPORT

Managing Director Fred Peivandi stated that there are no new updates regarding the COVID-19 pandemic as it pertains to the Road Commission. Staff is still working four 10-hour days, social distancing and wearing masks when social distancing is not possible.

Mr. Peivandi reminded the Board that there is a Transportation Asset Management Webinar for local officials on May 27, 2020 from 9:00 am until 12:00 pm.

Mr. Peivandi stated that the first GCRC Roadway Newsletter was just published and all Board members and employees received a copy.

Engineering Director Eric Johnston listed the current ongoing GCRC construction projects:

- Clio Road
- Two Bridge Projects have started Mt. Morris Road and Grand Blanc Road (both using aluminum box culverts)
- Grand Wailea Subdivision
- B2 Paving Projects
- Dort Highway Extension project we are waiting for plans from the consultant then we will bid that project out in two phases.
- Pre-construction meeting for Hill Road from Saginaw to Center Road. This will be a total reconstruction project.
- Pre-construction meeting for Van Slyke Road from Maple Road north to Bristol Road.

COMMISSIONER'S CONCERNS

<u>Public Relations</u> - Commissioner Arceo stated that with all of the ongoing Road Commission projects, he recommends that we keep the public informed of all the current projects underway. Managing Director Peivandi stated that we update our website, Facebook page and issue media announcements on a daily basis to keep the public aware of current road projects.

<u>GCRC Roadway Newsletter</u> – Commissioner Kautman-Jones asked staff to email the Board of County Commissioners, Township Supervisors as well as Legislators a copy of the GCRC Roadway Newsletter for their information.

<u>CRASIF Dividend Distribution Letter</u> – Commissioner Kautman-Jones commented that she had received a letter from CRASIF regarding the dividend distribution that GCRC will be receiving. Staff stated that they would present this information to the Board at the June 02, 2020 board meeting.

<u>Hands-Free Sanitizer Stations at the GCRC Entrances</u> – Commissioner Kautman-Jones asked staff to look into getting hands-free sanitizer stations at all GCRC building entrances. Staff will look into the cost of these.

Genesee County Dams – Commissioner Mandelaris asked for a status on the Genesee County Dams. Eric Johnston stated that both the Atlas Dam and Argentine Dam are in good condition. Mr. Johnston said the Argentine Dam was just inspected yesterday by the State of Michigan Environment, Great Lakes and Energy Department (EGLE) and that the Argentine Dam water level has returned to normal and we were able to open the secondary gates and one of the main gates. Mr. Johnston said the Atlas Dam study has been completed. In October, we will authorize the consultant to do the improvements that the EGLE recommended. Mr. Johnston added that the rain that Genesee County received was much less than what the Midland area received.

Chairperson Dickerson extended his condolences to Fleet Maintenance Facilities Manager, Ms. Kendra Love-Brezzell and her family on the passing of her daughter.

Chairperson Dickerson congratulated Maintenance Director Mr. Anthony Branch on being named Beecher High School's new head football coach.

Chairperson Dickerson, without objection, adjourned the meeting at 10:41 a.m.
