PRESENTATION

Mr. Joe Kowalski, CPA, Partner, Plante Moran, Ms. Amanda Cronk, CPA, Senior Manager, Plante Moran and Mr. Garrett Gauthier, Staff Auditor, Plante Moran, presented their findings to the board regarding the audited financial statements for fiscal year ending September 30, 2020. Ms. Cronk stated that she wanted to thank Finance Director, Tracy Khan, her staff and Managing Director Fred Peivandi for all of their help with the audit. Mr. Kowalski commented that due to the COVID-19, the audit had to be performed entirely remotely and said the audit went very well and the staff was very responsive. Both Ms. Cronk and Mr. Kowalski stated they were able to conduct their normal audit procedures even though the audit was held remotely. Ms. Cronk congratulated the Road Commission on a clean opinion, which is the highest level of assurance of your financial statements.

Mr. Gauthier stated the biggest changes to revenue and expenditures on the financial statements were due to the Dort Highway project. The road commission had a twelve (12) million dollar decrease in revenue from the previous year due to the Dort Highway project but this was expected because the Dort Highway revenue was recognized in the previous year. Expenditures increased by six (6) million dollars due to the Dort Highway project. Mr. Gauthier stated that through 2021, the road commission would continue to see expenses related to the Dort Highway project.

Commissioner Arceo commented that he appreciates the amount of effort put in with reference to the audit by the Finance Director, her staff and Managing Director Fred Peivandi. On page 2 of the report, Commissioner Arceo cited that Plante Moran stated they had no significant difficulties in dealing with management in performing and completing the audit.

Ms. Cronk agreed with Commissioner Arceo's comments and stated that they are grateful that the GCRC team was so helpful. Ms. Cronk commented that Plante Moran's letter of internal control stated that the audit found no material weaknesses or deficiencies this year, no journal entries were needed and there were no internal controls that were lacking. In addition, Ms. Cronk said everything went according to plan and they had no deviations from the plan during the audit. Areas Ms. Cronk mentioned that should be continuously followed in the future were any legislative changes that may occur; continue to focus on cyber security and legacy cost controls. Ms. Cronk congratulated the road commission on being proactive in the legacy cost controls they currently have in place. Ms. Cronk also recommended that the Road Commission keep 3 months operating expenses or roughly 20 million dollars in their fund balance, which currently GCRC has a fund balance of 35 million dollars.

Vice Chairperson Mandelaris commended Plante Moran on Notes 9 and 10 of report.

Chairperson Dickerson requested a motion be made to accept the presentation by Plante Moran on the audited financial statements for fiscal year ending September 30, 2020.
