Cook Road Complaint - Commissioner Lane thanked Director Anthony Branch and the Maintenance Department for handling an issue a resident had called her about on Cook Road. Mr. Peivandi thanked Anthony Branch and his department for responding to the Cook Road resident so quickly. Commissioner Lane said the Road Commission took care of the problem on a holiday and she was very thankful for that. Mr. Branch commented that he went out to the address and then he called the district supervisor and he handled the problem.

<u>Legal Services</u> - Commissioner Elkins commented on the merging of the Michael R. Kluck & Associates law firm with the Loomis law firm asking if this would be a good time to bid out (RFP) a request for legal services and stated the Board might consider this.

<u>Lillie Road Bridge over the Shiawassee River</u> - Vice Chairperson Mandelaris asked what happens to Lillie Road once the bridge is removed. Staff responded that the bridge is too expensive (approximately 2.5 million) to completely replace so each end of the road will have a cul de sac added. Mr. Alex Patsy stated that this is a low traffic volume road (less than 50 cars per day) so it will not affect many motorists.
