Commissioner Mandelaris commented that he had the opportunity to review the Workshop minutes and agreed with Attorney Cascini when he said within an organization; you have the roles as well as personalities. We need to think about this reorganization while covering up the names. You have to remove the names from these positions and focus on functions. Mr.

Mandelaris noted that no titles are being changed to the positions nor is anyone's compensation changing. Mr. Mandelaris added that the public might receive this as negative in a bias way but said that he does feel we have an obligation to make this the best organization as possible.

Commissioner Lane said that she concurs with Mr. Mandelaris adding that we are looking at functions and how to work better as an organization. She also wanted to thank Mr. Dellaposta for updating the reorganizational charts with the additional information she requested.

Commissioner Arceo agreed with the comments made by the other members and said this is a good move in reference to this organization.
