#### BOARD OF ROAD COMMISSIONERS' DECISIONS

### **DISCUSSION**

<u>Fiscal Year 2023 Proposed Budget</u> – In a memorandum dated August 31, 2022, staff requested the Board approve the removal of the Proposed Budget for fiscal year ending September 30, 2023 from the table for public viewing and further, that the Board adopt the Proposed Budget for fiscal year ending September 30, 2023, with revenue and expenditures totaling \$92,329,525. (Copy filed with official minutes.)

Commissioner Dickerson commented that he is opposed to the proposed budget for fiscal year ending September 30, 2023 because it does not include a Human Resource Administrative Assistant position. The Benefits Coordinator, who formerly held this position, was promoted to her current job; but her job description does not include assisting the Human Resource Director with her disability. Mr. Dellaposta stated that the job duties are included in the Benefits Coordinator's job description. Mr. Dickerson added that the Benefits Coordinator is a job in itself and added when Ms. Grant retired, Ms. Pearson replaced her and we never replaced the Administrative Assistant position. Mr. Dickerson said when the Managing Director needed help, the current GCRC Chairperson promoted Randy Dellaposta as Operations Director to assist Mr. Peivandi.

Commissioner Lane asked if the Road Commission is helping and assisting Ms. Poplar with her disability. Mr. Dellaposta stated that yes; we are continuously doing things to assist her.

Mr. Dellaposta added that Ms. Kendra Love-Brezzell has been promoted to Director of Fleet Maintenance & Facilities and Mr. Dellaposta is stepping out of this department.

Mr. Elkins added that Mr. Branch is not losing his position. When Mr. Branch decides to retire, we realize that it will be difficult to replace someone with his vast knowledge of the Maintenance Department. This department will be re-organized to include two Superintendents instead of a Director.

Having greater friction helps to keep vehicles in their lane on slippery pavement around curves and helps the driver to stop.
