<u>Representation for the Genesee County Road Commission Employees</u> – In a letter dated September 14, 2022, Mr. Jeremy Tripp notified staff that effective immediately, SEIU Local 517M disclaims interest and will no longer represent employees working for the Genesee County Road Commission. (Copy filed with official minutes.)

Letter Correspondence from Mr. Ed Jacques, Director of Technical, Professional and Officeworkers Association of Michigan (TPOAM) – In letter dated September 15, 2022, Mr. Ed Jacques, Director, of the Technical, Professional and Officeworkers Association of Michigan notified Mr. Peivandi that official certification of TPOAM as the exclusive representative for GCRC non-supervisory employees will be issued next week. TPOAM will abide by the current contract formerly held with SEIU (expiration 12-31-2022) until a new agreement is negotiated. (Copy filed with official minutes.)

Vice Chairperson Lane commented in response to the two letters in correspondence, that the employees that are represented at the Road Commission by SEIU, voted last week to change their union representation which is the reason why Mr. Tripp and Mr. Jacques sent their letters to the Managing Director.

Attorney Cascini added that this is considered an 'RC Petition', which states that the employees decided within their bargaining unit to change their union representation. The Road Commission took no position as to this and said our employees have the right to choose their own representation. Attorney Cascini added that we look forward to working with Mr. Jacques and the TPOAM organization.

Vice Chairperson Lane asked staff about the functions of a Gradall. Mr. Dellaposta replied that the Gradall is used at every district garage for ditching as well as for other road maintenance operations. Gradalls have a bucket with an arm that allows them to ditch and articulate. It is also drivable and has two cabs. The Road Commission has seven (7) Gradalls, one for each district and one (1) spare. Commissioner Mandelaris commented that he has seen them lift objects up and Mr. Dellaposta answered that we do use them for lifting crosstubes and placing them in the roadway.

MANAGING DIRECTOR REPORT

<u>Request for Proposal for the Metro District Garage</u> – Mr. Peivandi said that the Road Commission received nine 'request for proposal' for the Metro District Garage project. He added that we would be screening those proposals to narrow down the candidates.

Commissioner David Arceo Resignation - Commissioner David Arceo announced his resignation to the GCRC Board and staff adding that his last day will be September 30, 2022. Mr. Arceo added that he presented his resignation to the County Board Administrator, Mr. Josh Freeman because he provides administrative support to the county board. He thanked the Board members and staff and stated it was an honor serving on this board at the Road Commission.

Chairperson Elkins, Vice Chairperson Lane, Commissioner Mandelaris and Commissioner Dickerson thanked Commissioner David Arceo for his commitment, service and guidance that he has provided to the Road Commission during his term.

Managing Director Peivandi extended his appreciation to Commissioner Arceo for his dedication and service to the Genesee County Road Commission.

<u>County Road Association Conference, Traverse City, MI</u> – Vice Chairperson Lane commented that the CRA Highway Conference that was held September 13th thru the 16th in Traverse City, was very informative and added that she attended a session she would like to share the information with to other organizations regarding drugs legally bought at gas stations. Ms. Lane said she feels this information should be shared with law enforcement agencies.

Chairperson Elkins said he also attended the CRA Conference and stated that the information he received at the conference was very enlightening and beneficial and he had the opportunity to meet many other individuals from other road commissions while at the conference.

<u>GCRC County Maps</u> - Commissioner Mandelaris inquired about the status of the GCRC County Road Maps that are being updated. Eric Johnston answered that the second proof has been submitted to the printing company so we should be getting that back for one last review

and once we give our approval, they can print them.
