#### PUBLIC ADDRESS THE BOARD

Atlas Township Supervisor, Shirley Kautman-Jones addressed the Board regarding the Goodrich Tower assignment to EIP Holdings II. She asked the Board to give special attention to the lease agreement with the new assignment because the current owner of the Tower has not paid their [personal] taxes and is in arrears to the Township in excess of \$22,000. Ms. Kautman-Jones explained that personal taxes on equipment are different from real taxes, which makes it more difficult to collect. Ms. Kautman-Jones added that the only option the township has is to padlock the site restricting access to any owner until the township is made whole with the taxes in arrears.

## **BOARD OF ROAD COMMISSIONERS' DECISIONS**

#### DISCUSSION

Intergovernmental Agreement for Road Maintenance with the City of Linden and the Road Commission – In a memorandum dated November 16, 2022, staff requested the Board approve the Intergovernmental Agreement for Road Maintenance between the City of Linden and the Road Commission. (Copy filed with official minutes.)

Commissioner Mandelaris asked if we have had an agreement with the City of Linden before regarding road maintenance. Staff stated that yes, this is an extension from last years' agreement, it was a one-year agreement prior and they wanted to extend this to two years. Commissioner Mandelaris recommended that the last sentence in the agreement be removed due to date inaccuracies.

Chairperson Elkins asked if this agreement will affect the work we perform in the townships at all. Staff stated no, because the agreement states that any township work takes priority over road maintenance performed in the City of Linden.

Commissioner Lane asked if any other smaller cities have a road maintenance agreement with the Road Commission. Staff answered that no, they do not.
