CALL TO ORDER

Chairperson Elkins called the meeting of the Genesee County Board of Road Commissioners to order at 10:01 a.m. The meeting was held in the Board Room of the Genesee County Road Commission, 211 W. Oakley Street, Flint, Michigan 48503-3995.

Mr. Dickerson agreed with Mr. Mandelaris and stated the reason of waiting until the completion of pending lawsuits, which include the Managing Director. He added that the contract for Managing Director only benefits the current Managing Director and not future candidates. Mr. Dickerson also requested a future closed session with Attorney Cascini to discuss this matter.

Ms. Lane added that at least the election of the officers should take place at the present meeting.

Mr. Elkins stated that this was a similar situation to 2021 when several Commissioners were up for reappointment and elections were still held.

Attorney Cascini addressed Mr. Dickerson's concerns regarding a new contract for the Managing Director and offered to respond with a written legal opinion.

Mr. Elkins asked the amount of the 10% allocation for this project. Mr. Johnston stated amount is \$98,000 and only includes the construction and not the sump collector system. Mr. Elkins then asked Mr. Peivandi about the cap that was placed on Townships for utilizing allocation funds for subdivision projects. Mr. Peivandi replied there is a cap and if there are funds leftover at the beginning of the year, a Township can go over their cap and utilize the remaining available

funds not used by other Townships.

Mr. Arceo asked for a better explanation of the breakdown of the funding for this project. Mr. Johnston explained it is 100% a cost of the Drain Commissioner's office and Mr. Peivandi added that 95% of the participation would come from MDOT with the Drain Commissioner's office incurring 5% of the project cost.

<u>Managing Director Job Description</u> – In a memorandum dated December 28, 2022, staff requested the Board approve the revised job description for the Genesee County Road Commission Managing Director position. (Copy of memorandum filed with official minutes.)

<u>ACTION TAKEN</u> – Motion by Ms. Lane, seconded by Mr. Arceo, to approve the amended revised job description changing requiring the listed education **or** experience instead of both requirements, and change the bullet points to numbering in the education or experience portion of the description.

Mr. Elkins stated that the current Board of Road Commissioner's is better qualified to make the decision on the job description because of the amount of experience of the current members. Ms. Lane agreed and added that the job description is not for a particular person but for a particular position.

Mr. Mandelaris would like to see some of the changes that he suggested be implemented into the Managing Director job description. He gave an example of changes the education **and** experience to read: education **or** experience. Mr. Mandelaris would also like the new Board to approve this document. Attorney Cascini responded requesting clarification from Mr. Mandelaris to ensure his suggestions are incorporated into future re visions.

Mr. Dickerson stated that the current proposed job description prohibits current employees with extensive experience from being considered in the future because they may not meet the college experience requirement.

Ms. Lane added that the knowledge of Civil Engineering is important in this type of position.

Mr. Peivandi questioned if the education and experience should be changed to read education or experience. Attorney Cascini replied stating the current document has four qualifications that need to be met. He added that the wording is the Board's preference.

Ms. Lane pointed out that the document has bullet points under the education and experience section and it should be numbers instead of bullets.

Ms. Cummings also agreed that the job description should match the type of individual that would fit that qualifications needed not a specific person.

Mr. Elkins also commented that the Road Commission is pro education and does offer some education reimbursement to employees provided the education is relative to Road Commission work. Mr. Mandelaris added that the reimbursement is for one course a year.
