Mr. Massey asked who would be receiving these new computers. Managing Director Dellaposta stated they will replace outdated computers within the organization. Mr. Massey then asked what happens to the outdated computers. Mr. Dellaposta replied that the computers are cleared of information and then put on the government auction site, GovDeals. Commissioner Gehringer asked if or can these outdated computers be donated to other nonprofit organizations. Mr. Dellaposta replied that there is language in the policy to allow for donating and can be discussed with future outdated computers. Mr. Gehringer added that he knows of some places that refurbish donated computers and then give them to nonprofit organizations. Ms. Lane added there are also places that refurbish and donate to school districts in need.

Chairperson Elkins stated the Board members will receive a copy of the current policy to review and to discuss updating if needed to allow donating of outdated equipment to other organizations.

Commissioner Smith asked if there have been a lot of carcasses picked up by Respectful Removal. Deputy Managing Director Johnston stated the maintenance department receives notifications of a carcass, RC staff will then go out and see if it can easily be moved. If it cannot be moved by staff, Respectful Removal is then contacted to go and pick up the carcass to properly dispose of it.

There is also a new policy being reviewed by legal counsel addressing deer carcass removal which will be brought to the Board in a future meeting.

Ms. Lane asked that in future references to this organization, it could be noted that it is Troy & Banks of Buffalo, NY since it could be confused with Troy, MI. She also asked if there was a similar company in Genesee County or in Michigan that could do the same audit for the Road Commission. Ms. Khan replied that she is not aware of any and if another company is utilized, it would have to go out through the bidding process. This company was also utilized by other municipalities, so the legwork has already been completed for the Road Commission.

Mr. Gehringer asked if the results would impact other Genesee County government agencies such as the Townships with regards to streetlights. Mr. Dellaposta replied that this audit may not impact other agencies as it will be looking at the invoices charged to the Road Commission, looking for inappropriate charges, double payments, meter readings and items of this nature. This will also include telecommunications.

Mr. Elkins added that from his experience, these companies can also audit street lighting costs. Mr. Elkins added street lighting should also be added to this audit. Troy & Banks will not only audit the billings, but also make suggestions on cost-saving changes that could save the Road Commission on utility costs. Mr. Gehringer also suggested the legal counsel review the contract with Troy & Banks.

### MANAGING DIRECTOR REPORT

Mr. Dellaposta informed the Board most of the 2023 audit field work has been completed and the auditors will be wrapping up their results by January 12<sup>th</sup>. The next step will be to prepare a draft of our final financial statements and there are no concerns found within the audit thus far.

90% of the Act 51 data has been calculated and a copy of the new fringe and overhead rates for fiscal year 2024 is now available.

The Human Resources Department is currently auditing the W2 1095C annual reports to ensure current Road Commission employees have accurate 1095C forms. They are also working on defining recruiting goals for the Road Commission and developing a strategic recruiting plan.

The Fleet Maintenance Department has received \$5,054.76 incentive checks from Consumers

Energy Business Efficiency Program. The program is to give incentive to businesses to purchase energy efficient equipment to help reduce energy usage in Michigan. Chris Anspach, stockroom/facilities supervisor, has been instrumental in working with the Road Commission Representative to ensure that when upgrading and replacing light fixtures and equipment, they are replaced with energy efficient options. It is a very time-consuming project but can be rewarding for the Road Commission.

Metro Garage construction is progressing with footings now in place for the buildings.

The new GIS based complaint system will be implemented this week. This feature will be located on our website which will enable feedback to be sent to the resident when they submit an issue through this system.

The Road Commission has made employment offers to six potential equipment operators for first and third shift Trunkline Maintenance to fill vacancies.

The salt report that was distributed to the Board shows that the Road Commission had savings of \$71,000 for the month of November and a \$199,418 savings for the month of December as compared to the same period last year. It is noted that Genesee County has had minimal snow events this year as compared to the same period last year. Ms. Lane asked if there are savings, can these savings be directed to the best benefit to the Road Commission, the employees, and retirees if possible. Mr. Dellaposta will look at all of these options if the savings remain at the end of the year.

Ms. Dontje gave a brief overview of the Social Media, Outreach & Education Report that she provided highlighting the Road Commissions engagement with the community.

Mr. Dellaposta reminded the Board of the upcoming Highway Conference in March in Lansing. More information will be available at the next Board meeting.

### **COMMISSIONERS' CONCERNS**

Chairperson Elkins let the Board know that the Road Commission is looking at getting tablets or laptops for each of the Board Members in an effort to become more electronic. Future Board Agenda packets will be emailed instead of sending overnighting packets to members. Mr. Dellaposta added the hope is to have software available by the end of January that can offer the items needed by the members of the Board. If a hard copy of an item is requested, that will also be provided.

Ms. Lane commented that she looks forward to a bright 2024.

Mr. Massey commented that going forward he would like to see more transparency within the Board.

Mr. Gehringer congratulated Chairperson Elkins and Vice Chairperson Lane on their remaining in their position on the Board. He also added that he voted the way that he did because he

believes Chairperson Elkins has started a lot of initiatives and should have a chance to complete them as Chairperson. He also believes transparency is key and comes from the top downward.

Mr. Smith looks forward to an exciting 2024. He also said he is still getting to know his colleagues and still learning about the Road Commission. He also congratulated Mr. Elkins and Ms. Lane.
